

Taxes are due October 1st and become delinquent after December 31st. It is your responsibility to ensure payment of taxes. If you no longer own this property, or if you have questions, please notify the Revenue Commissioner's office at (251) 574-8530. If your mortgage company is expected to make payment, we suggest YOU confirm receipt of taxes before January 1st.

A \$5.00 late fee and 1% interest per month beginning JANUARY 1st will be added to the unpaid principal portion of bill.
