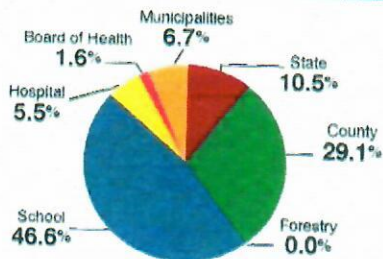

Taxes are due **October 1st** and become delinquent after **December 31st**. It is your responsibility to ensure payment of taxes. If you no longer own this property, or if you have questions, please notify the Revenue Commissioner's office at **(251) 574-8530**. If your mortgage company is expected to make payment, we suggest **YOU** confirm receipt of taxes before **January 1st**.

A \$5.00 late fee and 1% interest per month beginning **JANUARY 1st** will be added to the unpaid principal portion of bill.
