1 GENERAL PURPOSE AND SCOPE

With the timber destruction from Hurricane Ivan forestland is more susceptible to the spread of invasive plants. The threat of infestation increases with the amount of clearcut (openings) and invasive plants on or immediately adjacent to the forestland. For this reason areas that have suffered significant forest damage will be given priority in cost-share assistance to control invasive plants over less disturbed areas. Early control and containment of present invasive plant species outbreaks is the best management strategy.

The three invasive plants this cost-share assistance program will fund are Cogongrass, Privet, and Tallowtree. Cogongrass has rhizomes that allow the plants to quickly spread to disturbed areas and are so sharp they can pierce through a gopher tortoise's (a threatened species in Alabama) nest and eggs. The dense mats created by Cogongrass increase the area's flammability leading to more frequent and intense fires that could damage standing timber. Additionally, Cogongrass reduces the productivity of land.

Chinese and European privet are also a threat due to the dense thickets which monopolize available nutrients. The thickets prevent forest regeneration by blocking sunlight and eventually replace the native species. Cogongrass or Privet is more likely to be found in openings or along the edge of forests.

Chinese tallowtree, a shade tolerant tree, can grow in the forest understory and eventually replace merchantable timber. The advantages tallowtree has over native species is an early reproductive age (can disperse seeds by age 3) and a faster growth rate.

Federal funds granted to the AFC by the U.S. Forest Service will be used to financially assist forest landowners to control invasive plants. The funds will be used to reimburse landowners over a two year period for management practices that control Cogongrass, privet, or tallowtree. A priority system taking into account the invasive plant, amount of disturbance, and location of the infestation will be used to determine a landowner's priority and how the funds will be distributed.

2 PROGRAM DELIVERY OUTLINE

- A. The Alabama Forestry Commission (AFC) agrees to do the following:
1. The state office will announce a landowner **signup period (Nov 1st- Dec 8th)** and will accept landowner signups at local county offices for the duration of the signup period. The local county manager will serve as the technical service provider (TSP) and will inspect the property and complete the **“Technical Needs Form”** within 30 days of receiving the signup form. **All Technical Needs Forms should be turned into the Regional Management Specialists by Jan 31st.** The TSP will determine from this inspection whether or not the application is eligible, the total ranking priority points accumulated using the ranking criteria listed on the technical needs form, and the acres needed by practice. All Technical Needs Forms should be completed or reviewed by a registered forester.
 2. The TSP will forward a copy of the **“Landowner Signup/Agreement Form”, Technical Needs Form, and stand location map** for each landowner application to the Regional Forest Management Specialist **by Jan 31st.**
 3. The Regional Forest Management Specialists, the Forest Health Coordinator and Assistant Forest Health Coordinator will meet on **February 14th** to compile and rank all eligible applications received using the preset ranking criteria to determine appropriate distribution of the funds. (In the event of a tie priority will be granted to the landowner with the smallest amount of infested acreage). The Assistant Forest Health Coordinator will create a database to track applicants and approvals and will send landowner approval letters and the conservation plan by **March 1st** with instructions on how to request final payment after the practice(s) is (are) completed. The Assistant Forest Health Coordinator will also send letters of disapproval to landowners not receiving financial assistance. A copy of both the approval and disapproval letters will be sent to the TSP and Regional Forest Management Specialist.
 4. Landowners must contact the local county office after each practice has been completed. Landowners have until September 10, 2007, to complete all practices. The landowner must complete the Alabama Invasive Plant Control Program- Invoice Form (including landowner cost), a W-9 Tax Form and submit invoices (complete with appropriate receipts) annually for a maximum of 2 years.
 5. The TSP will inspect the property to check for landowner compliance and record at the bottom of the technical needs form whether or not ALL practices were completed each year according to the control treatment. Partial practice completions will not be reimbursed. A copy of this completed form should be sent to the Regional Forest Management Specialist, who will then forward it to the Assistant Forest Health Coordinator.

6. The AFC County Manager will complete a material receipt with two copies of the Landowner's Invoice, the Landowner Signup/ Agreement Form the completed W-9 tax form and the completed Alabama Invasive Plant Control Program-Technical Needs Form and send it to the Regional Management Specialist. A copy of all records should be maintained at the county office. The Regional Management Specialist should forward the completed package to the AFC Assistant Forest Health Specialist.

3 LANDOWNER ELIGIBILITY OF FUNDS

A. A landowner is eligible for program assistance if **ALL** of the following are met:

1. The landowner is an individual, group, association, corporation, Indian Tribe, or other legal private entity owning not more than 5,000 acres of timber producing forest land. See the definition of a landowner in section 3C.
2. The landowner is not receiving federal cost-share or annual payments for the same forest land that is being applied for the Invasive Plant Control Program.
3. The landowner agrees to control the cost-shared area the invasive plant is/was on at their expense for an additional two years (until September 10, 2009) if needed.
4. No single landowner shall receive more than \$7,500 in total cost-share assistance from the program. Cost-share payments will be \$75 per acre per year for two years. (Therefore up to 50 acres can be cost-shared for a two-year period per landowner.)
5. Approved activities must be in compliance with conservation plan recommendations which will be provided by the Alabama Forestry Commission and a copy provided to approved landowners. A final inspection will be made by the Alabama Forestry Commission prior to payment. Landowners must provide invoices and evidence that activities were conducted.

B. A landowner is or becomes in-eligible for program assistance if **ANY** of the following are met:

1. If any landowner, successor, or assignee uses any scheme or device to unjustly benefit from this program, financial assistance payments shall be withheld or a refund of all or part of any cost-share payments otherwise due or paid to that person shall be secured. A scheme or device includes, but is not limited to, coercion, fraud or misrepresentation, false claims, or any business dissolution, reorganization, revival, or other legal mechanism designed for or having the effect of evading the requirements of this program.

2. If any landowner or successor takes any action or fails to take action, which results in the destruction or impairment of a prescribed practice for the duration of the practice the landowner becomes in-eligible. Cost-share payments shall be withheld or a recapture of all or part of any cost-share payments otherwise due or paid shall be secured, based on the extent and effect of destruction and impairment.

C. Definition of a landowner.

1. The landowner is an individual, group, association, corporation, Indian Tribe or other legal private entity owning not more than 5,000 acres of timber producing forest land (or a person who has received concurrence from the landowner for practice implementation and who holds a lease on the land for a minimum of 10 years). Corporations whose stocks are publicly traded or owners principally engaged in the primary processing of raw wood products are excluded.
2. The landowner owns forest land in Alabama, which was damaged as a result of one or more hurricane or tropical storm during the 2004 hurricane season.

4 TSP FORMS & Conservation Plan
--

- A. The AFC foresters will use the Alabama 05-07 Invasive Plant Control Program “**Technical Needs Form**”. A copy of this form is located in the exhibits section of these guidelines. A technical needs form must be completed within 30 days of receiving the landowner signup.
- B. A **conservation plan** consists of the technical needs form, a stand location map(s), and specification sheets, as appropriate. Conservation plans will be completed within 30 days of landowner approvals. A forester must either prepare or review each conservation plan, as indicated by signature on the technical needs form.

5 APPROVED PRACTICES AND REQUIREMENTS

GENERAL POLICIES

- a. Consideration must be given to preserving and improving the environment. All Alabama Best Management Practices (BMP'S) for Forestry must be followed.
- b. Practices must be done in accordance with an approved conservation plan that complies with these Invasive Plant Control Program standards and specifications as determined by the Alabama Forestry Commission
- c. Herbicides used in performing practices must be Federally, State, and locally registered and must be strictly applied in accordance with authorized registered uses, directions on the label, and other Federal or State policies and requirements. Specific recommendations are listed in the Forest Management Sheets. More detailed chemical prescriptions may be obtained by contacting chemical herbicide applicators in your area.

You have been **approved** for the Invasive Plant Control Program (IPCP) cost-share assistance funded through USDA Forest Service and administered by the Alabama Forestry Commission.
